

# LGBTQ+ Benefits Guide

# Bayer has a strong commitment to ensure every employee has a right to be themselves in the workplace and to foster an inclusive and supportive environment for our LGBTQ+ employees.

Bayer understands the importance of providing comprehensive benefits that support the unique needs of our diverse workforce; as such, Bayer offers benefits and programs that are aligned with the Human Rights Campaign's Corporate Equality Index (CEI) criteria. Together, we strive to create a culture that celebrates individuality and prioritizes the health and well-being of every employee.

#### Family Planning and Legal Benefits

You are eligible for the **Adoption Assistance Program** and the **Surrogacy Reimbursement Program**, which may reimburse you up to \$7,500 for qualified expenses incurred in connection with the legal adoption of a child or up to \$10,000 for qualified expenses associated with a legal surrogacy arrangement. Additionally, Bayer provides **fertility treatment** coverage under the national medical plans with no diagnoses required. You also have the option to enroll in the Group Legal Plan through MetLife Legal during annual enrollment. This benefit offers access to a national network of quality attorneys for legal services, including will and estate matters, document preparation, family law, (20) hours of Reproductive Assistance Law coverage, and much more.

### Health Plan Coverage and Inclusive Care Services

You have the option to cover a same-sex spouse or domestic partner (and children) for the medical, dental and vision plans. Bayer's medical plans offer HIV treatment and prevention, such as self-treatment options, PrEP, PEP and ART. National medical plans take into account guidelines set forth by World Professional Association for Transgender Health (WPath), offering transgender-inclusive healthcare including hormone replacement therapies, medical visits, lab services and reconstructive surgical procedures related to gender affirmation. Travel and lodging expenses are covered when there is no in-network provider within 100 miles. Inclusive care services including one-on-one gender affirmation surgery counseling, inclusive provider searches, behavioral health and educational support are offered through the National Aetna and Anthem plans. Whether you need last-minute backup childcare and/ or adult/elder care, **Bright Horizons** can assist you in balancing the demands of life and work by offering a subsidy on ten (10) backup care days per calendar year. Or, you can substitute one (1) backup care day towards Pet Care or four (4) hours of virtual tutoring. For further childcare support, Bayer offers a 10% discount through **KinderCare**.

**RethinkCare** offers 24/7 access to step-by-step videos, resources, and exclusive content developed to help families in understanding, teaching and better communicating with children, including children with learning, social or behavioral challenges, and/or developmental disabilities. Rethink also offers twelve (12) free sessions, per year, with a dedicated parenting expert.
